## SDOS Birding Walks Risk Assessment Form: Sherwood Rough

Date of Assessment: February 2024 and updated by TB 13 October 2024.

Location: Sherwood Rough - please note also sometimes referred to as Fairmile Bottom and Rewell Wood because they are all adjacent to each other.

**Brief Description:** The first part of the walk includes one very steep incline, although the walk leader will try to use a route that cuts across the contour of the slope and this should make the ascent easier. The focus includes looking for Hawfinches in an area called Sherwood Rough. A walking pole is likely to help people with knee issues.

**Parking:** parking is in the lay-by on the A29, about a mile and a half south of the Whiteways roundabout. It is very long and there is parking for more than a dozen cars. Look out for the white food van at the end of the lay-by. The W3W is: ///blinks.simply.nosedive Note: be aware that there is another shorter lay-by about half a mile before, with no food van. **The announcement for this walk, via the user group, will always confirm the parking/meeting place.** 

**Clothing:** warm, waterproof clothing, no trainers, and walking boots or wellington boots required.
