**Location:** Dungeness area - including the RSPB reserve, beach, ARC pits and marshes. RSPB reserve is at Boulderwall Farm, Dungeness Rd, Lydd, Kent, TN29 9PN. What3Words: bulletins.resolved.arose. Grid ref TR06771847

**Brief Description:** This risk assessment covers a range of sites in the Dungeness area and participants need to be aware of this. It needs to be read carefully and the guidance from the outing leader(s) should always be followed on the day. If we are birding from public roads then be traffic aware.

**Suggested clothing:** Warm, waterproof clothing depending on weather conditions; strong footwear or wellington boots after rain. It can be **very cold** around Dungeness - the location is very exposed to the elements. In summer, sun hat and appropriate clothing for sunny/hot weather.

**Fluids:** Please bring sufficient fluids appropriate to the weather conditions.
